Procedure for candidacy

As it was adopted at the May 9th, 2012 APPA General Assembly, the union no longer sends the election documents to individual members at home. Since 2013, all documents pertaining to the General Assembly in which elections will be held are to be made available on the APPA website.

Any member wishing to be a candidate to any post up for election, must visit the APPA website at www.appa.qc.ca and consult the « Elections » section. This section contains the « Election Guide » providing all the information necessary, including the Candidate Registration Form.

Please note that only the original Candidate Registration Form signed by the candidate and three witnesses will be accepted. This form must then be returned to the APPA by regular or internal mail, before the deadline.

FORMS SENT BY FAX OR EMAIL WILL NOT BE ACCEPTED AND WILL AUTOMATICALLY BE VOIDED UPON RECEIPT.
